AMA survey looks for doc input on reform's real-life effects

 The AMA's survey asks physicians to identify those rules and regulations that are increasing their administrative costs, adding to their paperwork load or interfering with patient care. Topics addressed in the survey include easing the burden of the Medicare enrollment process; establishing greater flexibility for federal health information technology requirements; and expediting the implementation of some of the Patient Protection and Affordable Care Act's provisions related to administrative simplification.

The AMA released the survey during the group's three-day national advocacy conference in Washington. CMS Administrator Donald Berwick, in a keynote address Wednesday morning, told audience members that the four main themes to focus on in healthcare today are simplicity, modernity, security and proactivity.

"Too many doctors, nurses are in a paper-and-pencil system," Berwick said, drawing laughs when he added, "The day of the hunter-gatherer medical record, I hope, is reaching an end."

Berwick, who will testify before the House Ways and Means Committee on Thursday about the healthcare reform law, also said he is "very concerned" about the sustainable growth-rate formula and that he and President Obama are fully committed to finding a solution to the issue. Stating twice that rules for accountable care organizations are coming "very soon," Berwick said he hoped audience members would comment on his agency's proposed regulations. http://survey.gualtrics.com/SE/?SID=SV dgxK4u5fz0GZheQ


